1. PRESIDENT'S REPORT

PRESIDENT'S REPORT AUSTRALIAN PHILATELIC FERDERATION 2023 ANNUAL GENERAL MEETING

I am pleased to present my second report as President of the Australian Philatelic Federation. As most of you know I have been asked to do another term as President. This is an honour and a privilege.

During this past year we had another busy year catching up on all the postponed exhibitions from 2022. We had one national exhibition, which was WPS 100, held in Wellington New Zealand. Australia had well over 200 frames of exhibits at the exhibition as the Australasian Challenge was part of the exhibition. New South Wales won the challenge, beating Victoria by two points. In addition, we had the Hobart 2023 National One Frame Exhibition, two FIP exhibitions, Capetown 2022 and IBRA 2023 as well as two FIAP exhibitions NZ2023 and Taipai 2023.

Talking about postponed exhibitions, it is with regret that Melbourne 2024 FIAP International Exhibition has had to be postponed again. Australia Post is unable to support an exhibition in 2024 due to significant competing priorities as well as their move of the support office and archives. The exhibition will need to be postponed to the later part of 2025 and a new date will not be able to be confirmed until late 2023 or early 2024 when the Melbourne racing club has confirmed its racing calendar. The Melbourne 2025 Organising Committee with the support of our major sponsor Australia Post will continue working towards making Melbourne 2025 a success and a show that Australia will be proud of.

Daryl Fuller is to be congratulated for continually producing a very informative APF News report throughout the year. The November 2023 issue will be our last printed version. Due to high costs the executive has decided that from 2024 APF News will only be produced in a digital format.

Peter Allen has been diligently working with software developers developing the new Exhibition database. The old Showman was outdated and hasn't been used for several years. This has taken Peter hundreds of hours and I would like to on behalf of the APF thank Peter very much for all his work and effort.

Due to the high increases in costs, and especially airfares, the executive will be reviewing all the APF expenditure. It is regrettable that most likely the APF Frame Levy paid by exhibitors for international exhibitions will have to increase. The APF policy is to breakeven on all the basic costs for international exhibitions over a twelve-month period. There hasn't been an increase in the levy for over ten years.

In closing Australian exhibiting presence at National and International exhibitions has been strong in the past but in the last year the number of exhibitors have been decreasing both by attrition and fewer new exhibitors coming on board. The APF has struggled to get the required number of exhibits at several exhibitions this year. The challenge ahead is to engage more people to take up the hobby and get them involved in organised philately, be it at local, state, or national level.

Lastly, I would like to thank all Executives, Project Officers and Commission Delegates for their hard work and commitment to the APF and to this wonderful hobby of ours.

2. VICE-PRESIDENT'S REPORT

VICE PRESIDENT REPORT – August 2023 – Brisbane

2022/2023 has been a comparatively quiet year.

Australasian Challenge

At the States Council meeting we received suggestions on changes to the way the Australasian Challenge was held. A proposed new Australasian Challenge Rules document, reflecting the suggested changes, was prepared and sent to the New Zealand Philatelic Federation who have agreed to the new rules. The new rules are attached. The main changes are as follows:

- There will be a separate class in the exhibition for the challenge
- Challenge entries will not be eligible for best in show awards
- There will be 4 (not 6) entries of which some may be novices or youth
- 15 extra marks will be given to teams for each Novice or Youth entry

Strategic Plan

At the States Council meeting we got feedback from all States to our Strategic Plan In the main they were happy with our draft but wanted more emphasis on the APF leadership role and the provision of training and educational material for use by States and by Clubs. Peter Allen has identified a professional facilitator to lead us to finalise our aims and draft the new plan. We have agreed to a process to progress this. This includes a workshop in February to uncover:

- Strategic ideas for the future of the Australian Philatelic Federation
- Clarity about Goals, Objectives, Strategies and Actions
- Any process issues to ensure the ideas are further developed for implementation.

After this workshop we will be given a draft of the Strategic Plan that we will review and refine. We will distribute the plan to all States for comment before it is finalised.

Qualified FIP exhibitors list

I have maintained a list of exhibitors who are qualified to enter FIP exhibitions. This task will thankfully no longer be required once we have our strategic database in place. However, in the meantime, if anyone needs a copy to email exhibitors, please let me know.

Exhibitions

During the year I attended several exhibitions. ANPEX (Adelaide), Liberec (commissioner), Cape Town (assistant commissioner), New Zealand FIAP (Auckland) and Ibra International (Essen). At these exhibitions I attended several seminars in a variety of classes.

There have been difficulties receiving and returning exhibits since the APF is meeting regularly by ZOOM and not in person. That means there are no longer as many opportunities to use the APF to transport exhibits across Australia. Many exhibitors (and insurers) are reluctant to use Australia Post or carriers to send their exhibits to and from commissioners.

AUSTRALASIAN CHALLENGE RULES & REGULATIONS

Objectives

The Australasian Challenge team-based philatelic competition between the States and Territories of Australia and the North and South Islands of New Zealand. It seeks to attract the best exhibits from each participating area while rewarding the participation of novice and youth exhibitors. The winning team will be winners of the Ed Druce Memorial Trophy, a perpetual trophy commemorating the original proponent of the Challenge.

The appropriate Australian State Councils and the New Zealand Philatelic Federation make formal entries to the Challenge. For Australian entries, it is the responsibility of State/Territory Councils to select the participants and to arrange for the completion and submission of the individual entry forms, payment of frame fees through their Commissioner/Judge and to ensure delivery of the exhibits to the Exhibition.

1. Challenge format

- The entries for the Australasian Challenges will be kept in a separate class in the exhibition (much like the championship class in FIP exhibitions)
- Where possible the challenge exhibits be shown separate from the national exhibits. If keeping them separate is not practical for the exhibition the exhibit must be clearly marked as being part of the challenge.
- The challenge entries will be judged and provided with a national result (and could therefore qualify for FIP).
- The challenge entries are not eligible for any grand or best in class prizes. NZ queried this rule
- The challenge entries should have their own allocated prizes, including at least a best in challenge. The exhibition could allocate others, especially if the challenge included novices and youth.

2. <u>Composition of a Team Entry</u>

- Each team should have a total of 4 entries each from different National Classes, however, entries from Novice or Youth exhibitors may come from the same class as one of the other entries. If this rule is not adhered to then a penalty will apply to the team score.
- Teams can include Novice or Youth exhibitors.
- Teams with less than 4 members may still participate in the Challenge.
- Each team member can only enter one exhibit.
- No member of the Jury or close relative can enter an exhibit in the Challenge.
- Each entry must comprise a total of at least five (16 sheet) frames; however, a novice entry can be in the range of 2-5 frames. A youth entry must accord with the range appropriate to the age of the exhibitor, as described in FIP/APF/NZPF rules.
- Teams can include exhibitors who are not resident in the team's state/Island but who are members of a Society from that State/Island.

3. Classes

- All FIP and Australian and New Zealand National classes are allowed with the exception of the Frugal and Literature classes.

4. <u>Novice Exhibitor</u>:

- 'Novice' is defined as an adult exhibitor who has not previously obtained 70 points or more in a National Show (in Australia, New Zealand or elsewhere). This means an earlier exhibit in any class except 1-frame or literature.
- The novice entry can be in the range of 2-5 frames.

4. Youth Exhibitor:

- The number of frames must accord with the range appropriate to the age of the exhibitor, as described in FIP/APF/NZPF rules.
- Youth competitors who entered an earlier Challenge can also enter future Challenges, provided they remain within the age limits.

5 <u>Exhibits displayed in Previous Challenges.</u>

- Exhibits entered in previous challenges can be re-entered in future Challenges with the exception of the two exhibits that gained the highest marks in the winning team in each earlier Challenge.
- It is, however, permissible for those exhibitors to enter different exhibits in future Challenges.

6 Judging:

- All exhibits will be judged at National level using the FIP (or other approved APF) rules, regulations and marking scheme.
- 10 extra marks will be given to Teams for each Novice or Youth entry. Note: these extra 10 marks are not added to the result of the individual exhibits.
- 10 marks will be deducted from the team score for exhibits (other than youth or novice entries) which duplicate the class of another exhibit (other than youth or novice entries). Note: these extra 10 marks are not deducted from the result of the individual exhibits
- The marks for each of the four entries, plus any extra marks for novice or youth entries or penalties, will be totaled and the Team with the highest number of marks will be declared the Champion.
- Each individual entry will receive an Exhibition medal and certificate appropriate to the class achieved by the entry; in addition, mark sheets and critiques will be provided for individual entries.
- The jury will comprise accredited National judges from Australia and New Zealand. The Judge/Commissioners from Australia and New Zealand will be approved by the APF. Jury members will be selected to provide an overall balance of expertise appropriate to the exhibits and in relation to the geographical areas of the competing teams.

7 Winning Team:

The winning Team will receive the Ed Druce Memorial Trophy. Winners of the Challenge will hold the trophy until the next Challenge is held. Prizes will be awarded to each of the four members of the winning team.

The principal activities of the company in the course of the financial year were the promotion and development of philately and the provision of consultancy services to Australia Post. No significant change in the nature of that activity occurred during the year.

Profit

The net operating profit of the company after providing for income tax was \$8,931.

Dividend

Review of Operations

A review of operations of the company during the financial year and the results of those operations found that changes in demand have seen an increase in income of 17.11% to \$182,362. Expenditure of \$170,478 represented an increase of 35.34% on the previous year.

Notes to the Financial Statements

Australian Philatelic Federation Limited For the year ended 30 June 2023

1. Statement of Significant Accounting Policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Basis of Preparation

In the director(s) opinion, the company is not a reporting entity because there are no users dependent on general purpose financial statements.

The financial statements have been prepared in accordance with the significant accounting policies disclosed below which the director(s) have determined are appropriate to meet the purposes of preparation. Such accounting policies are consistent with the previous period, unless stated otherwise.

The financial statements have been prepared under the historical cost convention.

Revenue and Other Income

Revenue is measured at the value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at the end of the reporting period and where the outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

All revenue is stated net of the amount of goods and services tax.

Income Tax

The income tax expense or benefit for the period is the tax payable on that period's taxable income based on the applicable income tax rate for each jurisdiction, where applicable adjusted by the changes in deferred tax assets and liabilities attributable to temporary differences, unused tax losses and the adjustment recognised for prior periods.

Current and Non-Current Classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the company's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the company's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

Cash and Cash Equivalents



Cash and cash equivalents comprise cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Trade and Other Receivables

Trade receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any allowance for expected credit losses. Trade receivables are generally due for settlement within 30 days.

The company has applied the simplified approach to measuring expected credit losses, which uses a lifetime expected loss allowance. To measure the expected credit losses, trade receivables have been grouped based on days overdue.

Other receivables are recognised at amortised cost, less any allowance for expected credit losses.

Inventories

Raw materials, work in progress and finished goods are stated at the lower of cost and net realisable value on a 'first in first out' basis.

Cost comprises of direct materials and delivery costs, direct labour, and an appropriate proportion of variable and fixed overhead expenses.

Costs of purchased inventory are determined after deducting rebates and discounts received or receivable.

Stock in transit is stated at the lower of cost and net realisable value. Cost comprises of purchase and delivery costs, net of rebates and discounts received or receivable.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

Property, Plant and Equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line or diminishing value basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives.

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

Leasehold improvements are depreciated over the unexpired period of the lease or the estimated useful life of the assets, whichever is shorter.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the company. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Trade and Other Payables

Trade and other payables represent the liabilities at the end of the reporting period for goods and services received by the company that remain unpaid.

Trade payables are recognised at their transaction price. Trade payables are obligations on the basis of normal credit terms.

Issues of supply of the white paper we were using have arisen. The decision to change paper rather than accept a doubling of the price will certainly create resentment and anger in some exhibitors using white paper. It is my intention to have some reference to the change made on the website at an appropriate time in an attempt to lessen this fallout. I will be talking to Peter about this later.

11. CUSTOMS PROJECT OFFICER'S REPORT

The year of review to end of June 2022 for Customs purposes was busier than normal due to a backlog of postponed exhibitions being fitted into the exhibition calendar.

The APF uses a Customs Agent located at Tullamarine Airport who continues to handle our customs requirement in a professional and timely manner.

Our agent prepared 15 lots of paperwork for our Overseas Commissioners; a breakdown of this being –

Wellington 2022 (3) Auckland 2023 (3) IBRA 2023 (3) Indonesia 2022 (2) Cape Town 2022 (2) Liberec 2022 (1) Sharjah 2022 (1)

It should be noted that I only handle the Australian end for customs. It is the Commissioner's responsibility to liase with his/her destination county to ensure that the correct paperwork and procedures are in place that end.

It is critically important that Commissioner's returning to Australia have the previously issued paperwork with them; declare that they are carrying commercial goods and present themselves to Customs Officials at our border, so the return of the exhibits is recorded.

Whilst it is highly unlikely to be asked, Commissioners should be prepared to open the cases carrying the exhibits for customs inspection.

12. EXHIBITION DATABASE PROJECT MANAGER'S REPORT

APF AGM 30 Sep 2023

Showman Replacement – Summary of proposal for APF Executive 29.11.22

Background

The Showman Access Database was developed some 20 years ago (or more) but in recent years became increasingly unreliable due to its age and some inbuilt coding problems.

Attempts to re-vamp the current Showman Access database have been unsuccessful to date due to difficulties in finding a contractor who can take on the job.

The APF decided to explore a web-based database and has developed specifications for an online Exhibition database. Based on three quotes, Dotsquares, an international Indian-based IT company has been commissioned to develop the app.

Progress

After some 8 months of ongoing work, Stage 1, the transition of the original database with significant enhancements, to the web has been completed.

We are now in the process of adding new exhibition data from 2019 to date.

Stage 2 – Adding exhibition management functionality will proceed later in 2023. See below for details.

The new database will be demonstrated at the APF Future Directions forum.

Rationale for the new approach

Showman

- Showman has data on some 2,000 people including names, addresses, Exhibits, results, classes, and awards.
- Data current up to 2018 but not always complete.
- Various contractors refused to work with Showman in its current form (Access database) due to problems with the code.
- It is quite 'buggy' as is
- The data needs considerable clean-up and much detail is out of date.
- The app only works on personal Windows computers and needs Windows + the current version of Access installed.
- As received, the software was very out of date, only running on outdated and unsupported versions of Windows and Access

A new approach

Apps based on local computers are losing favour. Web-based apps have several distinct advantages.

The APF is currently unable to meet standard data privacy and security requirements regarding Exhibition data.

Why web-based?

- Putting Showman on a modern, professionally built platform could give us a clear pathway to maintaining an up-to-date database of Exhibitors and exhibitions in the future.
- Security Online data is considered more secure than locally stored data. Both carry some risks of loss or hacking.

- Accessibility Online data can be accessed by authorised users from anywhere and as required.
- User management We can manage who has access to what data and who can change data or run reports
- Updating One central database is easier to keep updated. Any changes of details can be updated in one place and changed details identified in an exhibition will not be lost
- Backup: Online data can be backed up automatically to secure cloud storage.
- Removing the need for users to have any software background (such as knowledge of Access 2016, Excel/Word)
- No need for users to have current software versions Access, Excel, Windows as the web version only needs a web browser
- Providing a simpler user interface
- Much Improved reporting ability
- It may also solve the problem of having to train specialised users if the new product can be made sufficiently intuitive
- A web-based app would be less reliant on the skills of specific individuals such as Johanna and me and would avoid future problems when an 'expert' is unavailable or has left the role

Issues

• We will have to develop an official data privacy and Security policy NOTE: Our current approach gives no certainty as to how and where Exhibitor data is stored, shared and protected

The New App

Enhancements to current Showman:

- Recording exhibition chairs, secretaries, and team leaders and linking them plus judges to the exhibits they judged.
- A unique ID for each exhibitor
- Exhibit status ie, current, retired, deceased
- Includes the provision of the current state-of-the-art inbuilt security, and user management.
- Address details are encrypted so in the unlikely event of a data theft, exhibitor street and town details cannot be read
- There is a senior Admin with the ability to edit all tables and add new items such as classes
- A second user level can add new data for a new exhibition as it runs and extracts reports during the exhibition. On the completion of the exhibition, the results would be locked and those users deleted
- Reporting and filtering of data would be comprehensive and reports provided as Excel spreadsheets. All the old Showman reports would be standard. Reports could be sorted by date, class, State, Award lever (e.g. 75 points or more) etc
- The website will not be a public site. It will not be able to be found via Google search
- Back-up of data will be automated. Backups should be stored on secure cloud storage

• Convert all current Showman tables to a web-based database

- add new items (Exhibition chair, secretary, team leader, all linked to exhibits they judged)
- Build reporting ability using the database
- Build file-up-loader to add all results since 2018
- Clean up current data

13. EXHIBITION SOFTWARE MANAGEMENT PROJECT OFFICER

EXHIBITION AIDE REPORT – JULY 2023

BACKGROUND INFORMATION

- Exhibition Aide ('X-Aide' for short) comprises a master Excel spreadsheet and a series of master Word documents, linked by mail merge.
- There is a separate Excel spreadsheet and set of master Word documents for each of the three levels: State, National / APF and International / FIP / FIAP.
 - The three levels all operate in much the same way making it relatively easy for users trained at one level to use any of the levels.

EXCEL SPREADSHEET

- An annoying Microsoft update in early April 2023 caused some merging issues. It took a bit of detective work to identify the cause. The culprit the Frames merge field was amended to Last Frame to fix the issue.
 - All of the macros, Word documents and User's Guides have been updated to reflect the merge field change.

WORD DOCUMENTS

- As noted above, all of the Word documents were updated in April 2023 to reflect a merge field change in the spreadsheet.
- NZ2023 requested Comments Sheets for its Youth entrants something not previously done at FIP/FIAP level.
 The Youth FIP Commissioner, Stephen Chan, approved the new Youth Comments Sheets.
- The current certificate master in X-Aide is in Portrait format. A landscape format certificate master was created in June 2023 for Swanpex 2023 (WA state-level). I will add this to the APF and FIP/FIAP set of Word documents to provide additional choice for users.

USER'S G UIDES

- I have put development of the X-Aide guides on hold (other than the amendments noted above), pending completion of the database project.
 - It is likely that some significant changes will need to be made to the current version of X-Aide to enable compatibility with the new database. Those changes will need to be reflected in the User's Guides.

EXHIBITIONS

- NZ2023 (FIAP International) was held in May in Auckland, New Zealand.
 - Leigh Gravestock was trained in X-Aide during NZ2023. She proved highly capable and a delight to teach.
 I am confident that she is able to operate Exhibition Aide without further training.
 - Issues worth noting:
 - To prepare an Exhibition Aide spreadsheet, exhibition organisers send me either scans or copies of the entry forms. Despite repeated requests, the NZ team never sent me any of the entry forms. I eventually received the entry details about one month before the exhibition date. By then, I was quite concerned that I would not have sufficient time to properly prepare.
 - The entry details I was finally sent had been recorded on a spreadsheet prepared by Leigh Gravestock. Leigh was not aware (rather, not been told by the organisers) to record the details on an X-Aide

spreadsheet. The spreadsheet Leigh used was not compatible with X-Aide, so all of that information then had to be manually re-entered to an X-Aide spreadsheet. A lot of wasted time and effort (Leigh's and mine).


- Norman Banfield spent many hours preparing judging sheets. He had not been told that X-Aide would have created the sheets in a matter of minutes. More wasted time and effort.
- The jury room was initially supplied with a WIFI printer. The WIFI quickly proved to be virtually useless, but it was more than a day before a suitable cable connection was installed.
- Hobart 2023 (National One Frame) was also held in May.
 - Peter Allan was trained in X-Aide for Hobart. Peter sought the training primarily to gain a fuller understanding of X-Aide as preparation for developing an interface with the new database.
 - Peter did not receive full training because he was also in the jury team.
- Swanpex 2023 (July, State multi-frame) used a state-level version of X-Aide.
- Perth 2023 will also be using X-Aide (November, National multi-frame exhibition).

FRAMES REPORT FOR AGM 2023.

Apart from Hobart 2023 there has not been a call for frames and as Tasmania now has a container permanently located there they are able to manage the frames themselves. I still get a call for advice and information but that is a minor matter. Their frames are well maintained and were very easy to work with apart from the usual problem of volunteers not tightening the top screws properly.

I still have one container to check, the one from Melbourne 2017, I am not sure what parts are in it and will have to remove a number of frames to be able to see what is there. There is no real urgency for this but it will be a project for some time in the next 12 months hopefully when there is some space between exhibitions so I can get a small team together for the job.

All containers have been re certified until 2024 but will need to be done again before Melbourne.

With the next call on containers being for Perth 2023, two containers will be sent over. These have been checked and are ready to go. I will be preparing the necessary paperwork shortly.

Consideration needs to be given to the locating of a container in the Eastern States, possibly Queensland but not necessarily in Brisbane. I suggest an approach be made to the QPC to find a suitable location, my thought would be Toowoomba. There is also the possibility of a site at the new PHILAS House location. I have floated the idea with John Moore and await his thoughts. This container could then be used for exhibitions in Canberra and New South Wales as well, which hopefully would reduce the transport costs in moving one from SA.

The hand trolleys used at Melbourne 2013 have been relocated with two in each container, but there are still some left over that I have stored in the other 10 foot container.

Some thought needs to be given to a replacement for me. By the time Melbourne comes around I will be 80. Handling the paperwork is not a problem, but the heavy work is out of the question even now.

18. APF News Darryl Fuller

Record of Forum held Saturday 8 October 2022

Forum Chairman: David Collyer (co-chaired with Frank Pauer) **Recorder**: Lionel Savins

Attendees:

The Forum was attended by all members of the APF and the State Delegates, a deviation from previous Fora, where the members of the APF Executive did not attend.

The Item Numbers are those listed in the Agenda issued at the Forum, and are detailed here in the same order that they came up for discussion.

1. Welcome and Introduction

The Chairman welcomed all attendees to the 23rd State Councils Forum and explained that the order of the Agenda subjects will not necessarily be followed, but will be used to identify each matter as it comes up for discussion. He also explained what would happen tomorrow morning when the joint session, took place. This would be on the subject APF Future Directions, and a separate Agenda was provided for this. In effect, there would be no Sunday Soviet on this occasion

All attendees were then asked to stand, identify themselves, and tell the Forum of any involvement in philately at club level and up and detail collecting interests. This included the Chairman and Recorder of the Forum.

3. E-bay Philatelic Fraud Tasmania Forgeries

Barry Gibson was invited to speak on the overprint forgeries from e-bay and referred the attendees to a paper issued by Ian McMahon. The speaker has completed a book on the Specimen overprints of Tasmania and had found that forgers had been in business for many years. He had concentrated on the stamps of Tasmania first and when he had sufficient evidence he approached the State Police who told him this was not in their area, so he would need to speak with the Federal Police. He then took the decision to buy some forgeries and then claim his money back to get more information on the forger. He was now looking for more State bodies to do work on this to gather more evidence to present a complete picture on the forgers.

Mike Kouwen queried how this would work, to set up in WA.

Tony Shields questioned whether this information should be published in APTA News – They would need to be careful if they were to do this.

Philip Levine asked whether contact details could be printed in the article, and the emphatic response was NO.

Peter Allen commented on the lack of police action – take the case on depending on value vs costs.

Mike Kouwen suggested that the proposals be sent to all the State Councils.

Geoff Kellow stated that the forgeries must be expertised if any action were to proceed, to which Barry replied that this had already been done, with Certificates from Ceremuga.

Tony Shields added that the matter should be referred to the F.I.P. - it is not just Australian but a world-wide problem. (the F.I.P. Fakes add Forgeries Commission has been made aware of this matter).

Bruce Chadderton asked for help in this as all Barry had done was Tasmania and the other States needed to be examined.

Frank Pauer commented that all Councils needed to look at this, and John Moore added that Fair Trading could be of assistance.

5. Founders of Australian Philately

Tony Presgrave opened this subject by saying that he began with the APO Awards criteria and modified them to set up the guidelines for this one. He had hunted for names of potential starters Australia-wide and struggled with Western Australia and Queensland prospects. The early period, from the 19th to the early 20th century provided 23 names. He then searched the 20th century up to 1950 for other names.

Geoff Kellow responded that this was an excellent idea and he had done a similar listing and also came up with 23 names, not necessarily the same. He suggested that a sub-committee, consisting of Tony Presgrave, Malcolm groom and Geoff Kellow should do this and present the results to the APF. This would be a one-off search, and the only requirements were that they must be dead and they had received no APF Awards.

Peter Allen asked whether RDPs would be eligible, to which Geoff answered that they would be included if they met the two conditions listed earlier.

Linda Lee added that research could find others, to which Geoff responded that if the search criteria were properly set, this should not happen.

Stephanie Bromser spoke very strongly on the value of such an award, and would very much like to see it come to fruition.

David Collyer asked that once the list had been decided, how would these be recorded? He suggested that this could be done in the form of a book or monograph. It was something for the sub-committee to determine.

Glen Stafford added that this would be formalised at the next APF meeting, scheduled to be held this afternoon.

Tony Presgrave completed the discussion by stating that he had listed the guidelines that he had used had been listed by him, and that these could be used as a start in this matter.

6. Judges' Leadership Training

Glen Stafford spoke at length on this matter, by stating that they must maintain the current list of Jurors. The next step was to raise the bar for jurors to move up to get Team Leaders and the like. The F.I.P. had done this and New Zealand was keen to follow suit. There were sessions on the APF website, and much ZOOM time was allowed for a Q & A session. He thanked all the speakers who were involved, and thanked those who attended for showing great interest in the programme.

Linda Lee stated that the course was great and added that getting new exhibitors was also most important.

Philip Levine asked whether the course was for team leaders, to which Glen responded that it was, and that it helps with their selection for an Exhibition.

2. <u>Electronic Publishing of Monographs</u>

The Chairman introduced this subject, stating that it had come from Ken Sparkes, and that there had been four entries in the recent Canberra Exhibition. He has done books on Sydney and Melbourne – a large book – electronically. The downside was that even though it was more readily available, he could not sell it. Is electronic publishing of value?

Glen Stafford commented that if on paper it is an easy matter to find out how many copies are in circulation. The Study group now have control of this, and the book is still free.

Marilyn Gendek added that electronic publications can be printed and sold. Large publications could be split to keep them to a suitable size for handling.

Peter Allen came in with the advice that Electronics was changing and updates could lose data. Digital publication is much better.

Darryl Fuller added that, if they accessed the web for data, they should include that date of access to their extract. He felt that hard copy was the way to go.

Stephanie Bromser commented that they could use the "print on demand" system.

Tony Presgrave replied that he had used this system for the "Departmentals", with the latest updates, printing 40 copies.

Geoff Kellow stated that he liked books. Philatelic literature will last longer than auction catalogues. Electronic copies are updated but not dated.

The last word came from Peter Allen who advised you could sell electronic copies as well as hard copies.

19. One Frame Exhibiting

Peter Allen advised that at F.I.P. level there is no Commission for this Class. He spoke on the original guidelines and the problems they had caused. (These were changed significantly at the F.I.P. meeting in Jakarta recently). The National One Frame Class Rules differ from the F.I.P. Rules and the APF had decided to change the National One Frame Guidelines to make them more approachable for Novice collectors. Peter explained these changes.

Linda Lee had a question on the CAPEX results and asked whether he was happy with them, to which he answered "Yes".

There was a general discussion on the "out of scope" problem. The loss of points scaled to the actual number of frames possible for the subject exhibited was the most discussed p[art of the paper. Even so, it was accepted that it was critical to use the One frame class at State Level to encourage new exhibitors, where the "out of scope" problem could be largely ignored.

20. <u>Pensioner Discounts for Exhibition Frame Fees</u>

Stephanie Bromser spoke strongly on this matter, stressing that it related to Commonwealth Concession Card holders only. She ended her speech with the comment that "anything that is good for the philatelist is good for philately".

Darryl Fuller spoke against the proposal, stating that every Exhibition needed every penny it could raise to make the Exhibition a success.

John Moore commented that we should do this. (who are "we"?).

Linda Lee added that at a meeting of the last Sydney Exhibition Organizing Committee the matter was reviewed and it was agreed that it would be too difficult with entry fees.

21. <u>Clarification of the Rules/Guidelines for Judging Open Exhibits</u>

Marilyn Gendeck spoke on this matter stating that the concept is broader than as described. "Open" is a separate Class. F.I.P. has recognised this Class. If used postally, picture postcards can be used in other Classes, based on the non-picture side of the card.

Darryl Fuller asked their use in other Classes.

Glen Stafford replied that we have F.I.P. Classes and non-F.I.P. Classes, so there are problems which are not currently resolvable.

John Moore suggested an APF Class as "Open Picture Postcards".

Ian McMahon added that picture postcards are permitted in Postal Stationery if they are postal stationery.

18. <u>APF News</u>

Darryl Fuller spoke on this. Because of problems of returned mail from international addresses, he could have to send the overseas magazine by email only.

John Moore added that, somewhere in the APF Charter, exhibition results should be included in the magazine even though it is old news. Most exhibitions no longer print Palmares results so the magazine may be the only source for this information.

Darryl responded by saying he would catch up with next issue.

17 Youth – APF and Scouting Bodies to Combine to Encourage Youth Collecting

Ian McMahon presented the paper written by John Vassalo, who was not in attendance. The paper is reproduced below:-

Presently, Youth is not getting into Stamp Collecting, so I propose that the APF take a completely look at this.

At the moment there are still Scout Badges that a Scout youth member can win for collecting stamps, so I suggest that an APF/Scout Association be appointed to discuss and get approval from the National Body that we can hold some activity at exhibitions that will give the youth member the badge. Once approved, I suggest the APF supports exhibitions to organise visits from Scout Groups to the exhibition.

The APF contact, through the relationship with the National Scout Body will be able to get contacts for the State Scouting Body to pass on the details of the Show, prepare handouts with details of the you can earn, possibly provide (pay for) transport, and might even be able to present the badges to those who do the work. We might want to organise a special badge (called a Campfire Blanket Badge that costs about \$3 each) to give to everyone who comes to one of our national Shows.

Glen Stafford stated that the only way to get involved would be to supply badges to the Scouts.

Peter Allen added that when he was a Boy Scout and wanted a badge, he had to go to a special examiner, such as the APF. John Vassalo should follow this up with the Scouts.

Russell Boylan added that the Scouts have a Worldwide Body and we should proceed to this level. It is over to you, John.

16. Guidelines for Judge Emeritus

The Chairman opened this with information that the Rules stated that this applied to Judges over 70 years of age. If they were not judging, why shouldn't the Rule automatically apply? What is the status of Emeritus Judges? They can be asked to judge generally to fill in due to an illness.

Ian McMahon added that there were Rules applying to this, in answer to a question from Linda Lee. Usually, physical problems cause this status (travel to other States, etc.).

4. Virtual Exhibiting and Exhibitions in Australia

Glen Stafford spoke on this, from his own experiences, having judged at five virtual Exhibitions. You are doing everything on your own and tend to spend more time than usual. Both the F.I.P. and F.I.A,P. do not accept Virtual Exhibitions as a step into International Exhibitions. It was a great exercise forced onto us by COVID, but he did not think it would continue. On the question raised by Stephanie Bromser, he did not think it could be extended to Literature.

Ian McMahon added that one exception could be those people who had become enamoured to it.

Peter Allen advised that some people used it to protect a very valuable collection.

Glen Stafford responded with the fact that normal Exhibitions finished when judging finished, but this did not apply to virtual exhibitions.

Russell Boylan commented that it was a cheap means of entry, since most Exhibition entries are costly these days

7. <u>The One-Up Club</u>

This was in the hands of Stephanie Bromser and Russel Boylan. Stephanie stated that this was really good for the exhibitor, and that the judges at an Exhibition should tick the box on the marking sheet for the exhibitor to follow this up with further action.

Bruce Chadderton advised that he has helped many exhibitors privately, not through the One-Up Club system.

Glen Stafford replied that he had used the One-Up Club to progress to International Gold medal status. Many of the changes recommended were very simple and easy to achieve.

8. <u>Changes to Requalification for Literature and Youth Judges</u>

Glen Stafford spoke on both of these matters. They were short of Literature judges in Western Australia, so the aim was to increase their numbers, based on a person's responses and their CV. This has worked, and they now have sufficient Literature judges.

On the matter of Youth, they are not getting enough entries in Exhibitions to train the judges, even though they now have some extra judges.

11. National Exhibitions

The Chairman introduced this subject, stating that the costs of holding a Full National Exhibition were very high, particularly in relation to the venue.

Glen Stafford commented that their last National Exhibition in Western Australia lost \$30,000, which meant that they now considered Half-Nationals only.

The Chairman responded that Sydney had made a profit at each Exhibition, in a joint venture with APTA. This applied particularly to the 2019 Exhibition where there was free admission.

John Moore admitted that there was a bit of a drawcard as combined Stamp and coin Shows. The trade side generally look after themselves, but all in works well also.

Glen Stafford added that the Shows should be held in close succession to get international dealers to attend as they can then be at both shows.

10. <u>Publications Assistance Programme</u>

The Chairman began the discussion by stating that there was, and still is, a programme through which authors can ask for assistance in publication. There is also a programme for researchers. How do we get the message across on these programmes? The level of assistances depends upon the task in hand.

Ian McMahon added that the loan could be paid in either cash or kind.

Linda lee asked whether they were getting too many or not enough people in the programme.

The Chairman replied that the latest recipient went direct to the APF, but the usual way was through the State body. This also applied to research.

Ian McMahon then advised that the De La Rue correspondence had now been digitised and was available on line.

25. <u>Election of Officers</u>

The current Chairman (David Collyer) and the current Recorder (Lionel Savins) were nominated and elected unopposed to carry out these duties at the Forum that will be held at the APF Annual General Meeting in 2023

24. <u>Cinderellas – Collecting and Exhibiting</u>

Tony Presgrave produced a long discourse on this subject, and it was attached to the Agenda for the Forum, and this was used throughout the discussion.

Ian McMahon stated that the current rules have many areas that need clarification, and suggested that they be rewritten for review.

Darryl Fuller added that they were big in Germany, and there is a push to resurrect them, but this action is currently on the back burner.

Mark Kouwen commented that the matter of Importance is a problem in that its meaning is unclear and it could be an unnecessary criterion.

Stephanie Bromser suggested that they use a similar class as guidance for Importance.

Ian McMahon added that it had been judged under Traditional rules in the past – not a good way for this subject.

Linda Lee asked whether we had separate Rules for Cinderellas.

Ian McMahon replied that the original set of Rules were included in the Notes to the Agenda even though they had been written many years ago. They need to be rewritten to bring them up to date.

It was then left to Tony Presgrave and Ian McMahon to review and update the Rules for Cinderellas.

22. Organised Philately and Paper Collectables Hobbies

The question had arisen as to what paper collectables can be used in the Open Class.

Frank Pauer asked why we could not have a separate Class called "Others".

Bruce Chadderton added that New Zealand had tried the "Others" Class, but it seems to have faded away.

Frank Pauer stated that we are losing our Exhibitor base and costs are rising.

Bruce Chadderton stated that he had made the point that years ago picture postcards were not considered. How do you judge some obscure collection that no-one has seen before?

Mike Kouwen joined in with the fact that there are some items that can be judges and others that cannot be judged.

Tony Shields joined the fray by adding that you have coins, sports cards, banknotes, etc., that are rarely exhibited that could be a major drawcard.

The Chairman added that at Olymphilex 2000 one entrant had a big display of Olympic Pins.

Ed Wolf told the room that Bathurst have been exhibiting odd items at their show, such as barbed wire, etc., and philatelic "Others" with great success.

15. How do you move Collectors into Exhibitors?

Peter Allen began this session by saying, for him, you start with a Club display at Devonport, followed by a 16-sheet display at Hobart, then move to the new One Frame system.

Tony Presgrave added that they have had special workshops on philately and have gained some exhibitors from these.

Glen Stafford noted that local clubs often ruin a bourse, but they need people to sell the idea.

David Figg noted that you needed to be organised to become an exhibitor.

Glen Stafford stated that they had spruikers at shows, and you get bits and pieces.

Stephanie Bromser told us we needed a different type of competition to create a stamp show and provide a display.

Mike Kouen added that Western Australia have many displays at both Club level and State level.

David Figg told that the Picture postcard Society held two such displays a year.

John Moore advised that Clubs in Newcastle have competitions. One uses 16 pages, while others have 6 pages based on the alphabet. It's surprising how the sizes of the entries expand as time passes. All are judged by popular choice.

Tony Presgrave advised that South Australia have run Congresses for years. They were originally designed for beginner one framers, but were destroyed by the appearance of gold medal winners. This will be changed to a top score of silver medal to restore equilibrium.

12. How can Organised Philately make Best Use of Social Media?

Glen Stafford began this by saying that any form of publicity was good publicity, but it needs a person to drive it. The APF used Youtube for their Team Leadership series.

Peter Allen came in with the fact that they use Facebook for photographs - it is easy to learn. The good thing is that it can be left there for a long time. The American Philatelic Society have very good presentations on Youtube. The Chairman mentioned the availability of Stampboards, which gets a lot of comment from many subscribers, and the fact that most Societies have a web page of some form.

13. The Electronic Provision of Exhibits

The Chairman lead off on this segment, commenting that from time to time the APF publish electronic versions of Gold Medal collections. However, they need to look at other important collections, e.g. Barbara Hancock's collection of peel and stick stamps. Should such collections be converted to their electronic versions and displayed accordingly?

David Figg commented that we must be very careful in this because Copyright could be involved when publishing material.

Frank Pauer added that the Royal Philatelic Society of Victoria have many such collections on their websites. What happens is that the final decision lies in the hands of the Exhibitors, and if you wanted to use them, the exhibitor involved must be asked beforehand to give permission for the collection to be displayed.

9. <u>Succession Planning</u>

Glen Stafford opened the discussion by stating that the Western Australian Philatelic Council have two ways for you to be replaced, one being that you die in harness.

Frank Pauer added that the Royal Philatelic Society of Victoria has eight Committee members, two of whom want to come off. They are having great problems in finding replacements.

John Moore added that in this day and age we can use Zoom for our meetings, so local living is now no longer a prerequisite.

Linda Lee added that as she was a Thematic collector, she was not strong in general collecting.

Peter Allen responded to John Moore's comment, stating that they had tried a Zoom meeting once. It was not a complete success, so the experiment was rejected.

Bruce Chadderton added that he had spent 12 hours in getting to today's meeting, and this could have been dispensed with had the APF used Zoom.

Glen Stafford stated that Zoom could be used for special parts of a long meeting, but not for the entire meeting.

FIP Postal History Commission Delegate's Report APF Annual Meeting 2022-2023

The Postal history Commission comprises:

Following the change of delegate for Germany meaning Thomas Hoepfner was unable to continue on the Bureau Bill Hedley was appointed to replace him whilst Gerald Herschl from Austria has filled the remaining invited position.

The revised Postal history guidelines approved at a commission meeting in May 2022 are available on the FIP website at https://postalhistory.f-i-p.ch

The FIP Postal history commission website continues as part of the FIP multi-site and is maintained by myself with all communications to delegates made through the website.

There were several activities undertaken by the FIP Postal History Commission during the past twelve months.

I gave an online presentation titled 'Understanding Postal History class 2C' through the German Philatelic Federation (BDPh) in April 2023 that was well attended. The presentation was meant to be recorded however a technical problem prevented them from doing so.

I chaired a meeting of the Bureau and Commission during IBRA 2023 during which a qualifying seminar on "Judging postal history" was conducted during IBRA 2023 by Bureau member, Dan Walker.

A number of opportunities to exhibit postal history were available in 2022/2023 since the last report with 20 Australian exhibitors participating in overseas FIP and FIAP shows. Nationally Hobart Stamp Show One Frame exhibition saw 12 postal history entries. The next full National is in Perth in November.

The Postal history commission future programme includes review the SREV's with the objective of simplifying them and removing repetition with the guidelines and also to develop further seminars in particular relating to class 2C.

26. FIP ASTROPHILATELY COMMISSION DELEGATE'S REPORT 2022 - 2023

There have only been two international exhibitions that included the Astrophilately Class, LIBEREC 2022 and IBRA 2023.

During the year, I judged at LIBEREC 2022 (Astro Team Leader), this was the first international exhibition to include the Astro Class in Europe for many years. There were 18 Astro exhibits with one exhibit from Australia (Ian McMahon-Canberra Tracking Stations – Large Vermeil).

At IBRA 2023 I was on the Aero/Astro judging team, here there were six Astro exhibits and five Aero exhibits.

The FIAP exhibitions that included an Astro Class were NZ 2023 and Savpex 2023. I was on the jury at both as a Team Leader. In New Zealand, Ross Newton's Apollo13 exhibit received a Vermeil. The Savpex 2023 was an international virtual exhibition in South Africa, I judged in several classes.

At the national level at the Hobart 2023 One-frame exhibition, my Woomera exhibit received Gold and at the Australasian Challenge 2022, my Rocket Mail exhibit received Large Gold.

I mentor several exhibitors from various countries.

Our FIP website (http://astrophilately.f-i-p.ch/) that I maintain, has now had over 1,000 visitors from some 60 countries. The People's Republic of China and the USA make up a quarter of the visits.

I have had invites from the vice president of the All-China Philatelic Federation and from the Astro delegate of the UAE's Philatelic Federation to hold seminars for their growing numbers of Astro collectors.

NZ 2023 – 38th Asian International Philatelic Exhibition and PSSA Meeting

NZ 2023 was an international exhibition held 4-7 May 2023 in Auckland. The Exhibition had 14 multi-frame, two one-frame, and a youth postal stationery exhibit. Michael Ho's exhibit of *King Willem III Netherlands East Indies Postal Stationery 1874-1904* received a Large Gold award as well as the International Grand Prix. There were Gold medals for Raymond Todd's *The Postal Stationery of Paraguay 1881-1928* and Rishi Kumar Tulsyan's *The Postal Stationery of Nepal, (1887-1959)*. Alastair Watson received 88 points and Felicitations for his one-frame exhibit *King George V 1½ d Lettercards – Bock Dies I & II*. A meeting of the FIP Postal Stationery Commission held jointly with the Postal Stationery Society of Australia, was held at NZ2023 with Frank Pauer presenting Aerogrammes of Australia. 
IBRA 2023 World Stamp Exhibition



IBRA 2023 was a world exhibition held from 25-28 May 2023 at Messe Essen, Essen, Germany. It was the first full world exhibition held in Germany since IBRA 1989. The postal stationery judging team (Emil Minaar, Juan and Mike Smith are shown on the right and Malcolm Groom and family in front of frames on the left. The postal stationery class included 25 exhibits with three Large Gold medals awarded including to Malcolm Groom from Australia for his exhibit, *Tasmanian Embossed Stationery* 1883 to 1912. The *Postal Stationery Collector*, the Journal of the Postal Stationery Society of Australia, received a



Large Vermeil in the literature section of the Exhibition which also included a number of postal stationery books, two of which are included in the literature section of this issue of PSC. The best exhibit in the class was Behruz Nassre-Esfahani's *Persia, Qajar Postal Stationery Issued 1876-1925* while Michael Ho also received a Lage Gold medal for *Honduras Postal Stationery*. In addition, there were six Gold medals awarded including to Philip Levine for his exhibit, *Gold Coast Postal Stationery*. A third Australian exhibitor, Frank Pauer was awarded a Large Vermeil medal for his exhibit, *Australian Air Letters & Aerogrammes – The Note Printing Branch Era*. IBRA 2023 provided the opportunity to meet postal stationery collectors from around the world including members of the Berliner Ganzsachen-Sammler-Verein [Berlin Postal Stationery Collectors Society] which had a Society booth at the Exhibition as well as Wayne Menuz, Editor of Postal Stationery. The FIP Postal Stationery Commission held a seminar on postal stationery judging which was presented by Ian McMahon, Mike Smith (UK) and Sammy Chiu (Canada). There was also a meeting of postal stationery societies convened by Wayne Menuz (USA).

28. FIP THEMATIC COMMISSION DELEGATE'S REPORT

The new Thematic Guidelines are now on our website and we will be using these for the first time in Perth. There are several changes and I encourage all judges and exhibitors to become aware of them.

I have been mentoring thematic exhibitors including a junior, a novice and a very experienced exhibitor.

Many thematic exhibits lose marks because they are closer to topical exhibiting. There is a clear need for a seminar on the differences between these two classes. I have agreed to do this in Perth 2023.

FIP COMMISSION

At the last FIP congress Tono Putranto was appointed the Chairperson for Thematics. However, as Indonesia is unfinancial, Daniel Szeto (Hong Kong), who was the secretary, is now the acting chairperson. There has been no news from the bureau since his appointment. We are waiting for confirmation of the new acting secretary.

As a result, there has been no progression on the bureau plans I put in my last report.

I am still trying to progress my aim of embracing Topical within Thematics. I also wrote to the commission to highlight the issue that the Youth thematic guidelines were based on our old guidelines and that little liaison has been done with the two groups to reflect our changes. For example, the word story is only used once (and only in one of the age groups). They also talk of it being best to have "Documents with a great matching between the stamp and the postmark" and that bothers me because this leads to a bigger use of FDCs and Maximum cards. There are many similar issues. Hopefully this will be resolved as it is confusing for youth exhibitors.

33. FIP FIGHT AGAINST FORGERIES DELEGATE'S REPORT 2022-2023

In the period under review there has been the FIAP Exhibition at Auckland (New Zealand 2023) and an FIP Exhibition at Essen, Germany. At both of these exhibitions I acted as Team Leader of the Expert Team.

The trend towards exhibitions being only four days in length is placing a degree of pressure on all Jury Teams, and this equally applies to the Expert Team. The time available to view the exhibits and identify items for further examination must be shortened if all of the paperwork required is to be completed on time for the closing session of the jury and presentation of the Expert Team report. At both exhibitions there were several jury members who doubled as National commissioners which also made for some problems if proper procedures (such as Commissioner attendance when removing items from the frames) is to be adhered to. Also at both exhibitions it seems the Commissioners-General had some trouble in organizing the attendance of all Commissioners for Expert Team meetings, and some commissioners had to be chased down.

As regards the work itself, occurrences of misdescribed items were noted, especially in the Thematic and Social Philately classes. More and more exhibits of more modern material are found to stamp artwork drawings and sketches, these usually deriving from the estates of the designers of the stamps. Many of these are quite crude since they represent preliminary ideas, however it seems unlikely that in many instances there would be an Expert committee willing to certify their genuineness. Speaking to some exhibitors, this may be a problem if these items are removed from exhibits in the future and certificates are requested. There is at present no reason to believe that faking is taking place, but it may become of concern in the future.

On the local scene reperforation of stamps continues to be a problem, with the forgeries getting better and presenting the Expert Committees with greater difficulties to be able to issue definitive certificates. Similarly, 'OS' punctures also present problems. In this case, however, the Perfin society has done a great deal of work in identifying the characteristics of the genuine perforating machines, and are now providing a certifying service which can be acceptable in international exhibitions. The certifiers require a 1200dpi scan of the stamp, and do not require the stamp itself to be submitted. Their certificates, of course, apply only to the puncture, and not to any other aspect of the stamps.

34. FIP OPEN COMMISSION DELEGATE'S REPORT

Class Development

Over the last year, as philatelic life returned to a post-COVID normal, initiatives that had been put on hold with respect to establishing this class at FIP level (ie accredited Open Class judges, setting up a commission, educational seminars) started to take place.

A group of principally Europeans (led by Peter Suhadolc and Birthe King) has established a Working Group to report to the FIP board on how Open Class can be managed and supported going forward. This report is expected to be tabled at the FIP Congress at Philakorea (Seoul) 2024.

In addition a number of countries have already nominated delegates to the Open Commission once it becomes operational.

At the IBRA exhibition in Essen, Germany there were a number of steps forward;

- Iva Mouritsen (Germany) became the first judge to complete a FIP apprenticeship for Open Class
- Birthe King presented on the importance of non-philatelic material in an Open Class exhibit
- An FIP Qualifying Seminar for Open Class, presented by Peter Suhadolc & Birthe King, was held.

The FIP Qualifying presentation is now available on the FIP website. It is titled *Open Philately FIP Qualifying Presentation – Thailand 2023*, presumably as it is going to be presented at Thailand.

The Birthe King presentation is available from the commissioner (kiwibrooce@yahoo.com).

Q: could we put them on the APF website if we had approval to do so or a link to them once they are on the FIP site [along with Jeff Long's Postcards presentations from Capetown and Taipei]?

The main points being made in these presentations are;

- Standard rules of exhibit development apply, so the exhibitor still has to focus on developing a strong title page, delivering a sound treatment of their subject, sharing their knowledge on all material used, rarity, condition and presentation.
- Philatelic material must be original whilst non-philatelic material should be original, <u>where</u> <u>possible</u>.
- Philatelic material **must be at least 50%** of the exhibit, whilst non-philatelic can be up to 50%.
 - Judging the percentage of philatelic vs non-philatelic material is best achieved by looking at each frame as a whole and making a visual assessment of each frame's composition, then averaging the estimate on each frame to come up with an overall %. Exhibitors aren't expected to be exact (ie 26.75% non-philatelic) but are expected to know if they have more than 50% non-philatelic material in their exhibit.
- The non-philatelic material needs to be given just as much focus in the exhibit as the non-philatelic from the point of view of;
 - o range of material
 - o description of each item, including explaining why it is a rare item if it is
 - relevance to the treatment and integration of it into the exhibit

• Postcards are considered non-philatelic when you show the picture side, and philatelic when you show the address side

Australian Involvement

Australian exhibitors have continued to support the class at national and international level. NOTE: there were no Australian national exhibitions held in the timeframe except the One Frame competition which occurred twice: ANPEX (Adelaide) and Hobart. Whilst WPS100 (Wellington NZ) was the only national exhibition supported by Open Class exhibitors.

Many exhibitors, particularly those starting out, are still getting to grips with the nuances of the class but results are improving and being able to access international presentations aimed at helping judges (and exhibitors) can only help.

FIP PICTURE POSTCARD CLASS DELEGATE'S REPORT – 2023 APF AGM

Following the motions passed at Congress last year which saw Picture Postcards move from experimental to fully fledged Class status and the creation of a Commission, paperwork was completed and submitted via APF Secretary, Ian McMahon appointing me as the Australian Delegate to the new Picture Postcard Commission.

I have received no word re acceptance, nor how the new caretaker Commission office-bearers are to be appointed. I have been in email discussions with Jeff Long who was to approach Abdullah Khoory (FIP Director with PPCs in his portfolio) as to next steps. I have intimated that I am prepared to be the FIAP Delegate. What appears to have transpired is that a "select group" are discussing/reviewing the SREVs and Guidelines as I was asked to provide what was in place in Australia pre Finlandia 2017.

I have also been advised that although I was appointed an FIP PPC Judge to the Experimental Class this is no longer in place now PPC are an FIP Class. Accordingly, more paperwork has been submitted through APF Secretary, Ian McMahon for both an FIP & FIAP Apprentice Jury Assignment. There are currently only two FIP PPC Jurors – Jeff Long & Seita Riita Laakso who both judged in Cape Town.

Jeff & Jenny Long conducted an FIP Qualifying Seminar on Picture Postcards in Cape Town, South Africa last November and again in Auckland last May. A PDF of the seminar has been placed on the FIP website and can be downloaded from there. Well worth a read.

Exhibiting-wise, PPCs featured in numerous exhibitions with Australian results being as follows – Sharjah 2022 – One entry – LS Liberec – Three entries – LV & 2 S Wellington – Four entries – 2 LG both with Special Prize and one Felicitations, 1 G & 1 LS Cape Town – One entry – LV SAVPEX – One entry – LV NZ 2023 FIAP – One multi-frame LV, one one-frame LV IBRA FIP – One multi-frame V Hobart One Frame – Eleven entries 4 G, 2 LV, 2 V, 2 LS & 1 SB

In 2023 another known opportunity taken up by Australians is Bangladesh (4 one-framers). SAVPEX, Taiwan & Thailand also have the class. It is also hoped that there will be a good representation of the class at the Perth Full National in November.

I was approached by Colin Fraser (USA) in January regarding doing a Zoom presentation on Picture Postcards as a curtain-raiser to MILCOPEX 2023 (23 & 24 September) on one of the two weekends preceding the Show. The other presenter will be Tim Bartshe. I have accepted and chosen Sunday 10th September at 3.00pm Central US time. My talk will be entitled "Putting postcards in the picture".

Bruce Chadderton & I will also be doing a tag-team PPC presentation in Dhaka, Bangladesh in September during the Bangladesh 2023 FIP Sponsored International Exhibition.

It has been disappointing at the very low support by Australian exhibitors for the First Day Cover Class this year but hopefully we have few entries in the Perth 2023 National Exhibition in November this year.

39. FRUGAL PHILATELY APF COORDINATOR'S REPORT

Frugal Philately is an experimental national exhibition class which includes a criterion which limits the financial value of the exhibit and imposes penalties if the limits are exceeded. It is designed to encourage the exhibiting of low value exhibits and encourage exhibitors who have limited financial resources. The class rules include penalties if the exhibit exceeds a value of \$1,000 (for 5 frames or an average of \$200 per frame for 3-4 frames). Exhibits are first judged by the philatelic jury and the value is then assessed by a separate panel (usually comprised of stamp dealers). Exhibits can be in any national class except for Youth and Literature.

The Frugal Philately Class continues to attract few entries. The last national multi-frame exhibitions to offer the Class were Canberra Stampshow 2022 and Newcastle 2022. There was one entry at Canberra 2022:

The next Exhibitions to offer a Frugal Class will be Perth 2023 and Canberra 2024.

PDC Report for APF AGM 2023

The PDC has not met since October 2022 at which the current members of the Council were re-elected for a further year on the motion of David Collyer seconded by Geoff Lewis.

The position of Secretary, held by Linda Lee, was declared vacant as her health prevented her from executing that role. Ed Wolf offered to act as secretary pro-tem and this was agreed to by the meeting.

The Open Day held 15th October was considered a success with the Interclub competition being won by the Burwood Club and the individual highest scoring entry was by George Petrides. Both club and George are to be congratulated on their results. The following clubs were represented Burwood & Districts Stamp Club, Castle Hill Stamp Club, Europa Collectors' Stamp Society, Manly-Warringah PS, Northern Suburbs PS, Parramatta PS, Philatelic Society of Australia, Philatelic Society of NSW and Smithfield Stamp Club.

On the same October weekend at the Liberec Exhibition in Prague NSW was represented by four entrants, two in Postcards, one in Literature and one in Polar. Graeme Englefield had the distinction of receiving a special prize at Prague for his entry in Antarctica scoring 95 points with his one frame entry, a rare achievement. Stephen Bennett was also awarded a special prize for his book The Antarctic Compendium.

At the Capetown 2022 exhibition held 8-12 November 2022 we had five entrants with Bruce Chadderton taking out a Special prize and a large gold for his *The Descent into the Abyss* in the Open class.

For the Wellington Exhibition held on the same weekend, a NSW team was entered for the Australasian Challenge. It comprised of Bruce Chadderton, Albert Cheung, Geoff Lewis, Lionel Savins, Darren Jones and Lewis Webb. They took out the other teams with a score of 506 which included two Large Gold and two Gold medals. The usual practice of funding the NSW team for the Challenge was followed.

Wayne Donaldson with his entry Sweden and Great Britain mail connections 1581-1880 received a well-deserved Large Gold for his 8-frame entry at the same venue.

The next PDC meeting was scheduled to occur on November 26 following the Philas AGM. However, as the AGM was a prolonged meeting, there was insufficient time for a formal PDC meeting, so it was agreed to suspend that meeting.

Since November 2022, the matters relating to Philas House have overtaken other matters of importance as a consequence, no PDC meeting has been called to date.

The Youth Group has met on two occasions with small attendance in both cases. No being unable to meet in Philas House was the cause of some discomfort but the Chatswood venue in the Dougherty Centre has worked out well. The venue cost of the meeting is funded by the PDC with the generous donation from the Smithfield Stamp club greatly assisting.

4-7 May saw the 38th Asian International at Auckland where NSW was represented by four entrants with Albert Cheung receiving a Special prize for his Postal History entry of Chinese Postal routes and David Collyer scoring a well-deserved Gold medal and felicitations for his Imperial connections 1925-1939 aerophilatelic entry.

The Tasmanian One Frame Exhibition held in Hobart from May 19-21 had seven NSW individuals enter Traditional, Postal History, Aerophilately and Polar classes indicating the diversity amongst our collectors. Graeme Englefield scored the highest marks with his Polar entry on *Mawson's Australasian Antarctic Expedition 1911-1914* receiving a Large Gold.

Another international event took place in Germany at Ibra 2023 held at Essen in the last weekend of May. NSW was represented here by Gert Ebing, Vijay Shukla and Geoff Lewis the latter obtaining a Gold with his Postal History entry *Mail Routes in the Atlantic, Pacific and Indian Oceans.*

There are still some exhibitions to come during the latter part of this year and no doubt we will have NSW members representing the hobby to our advantage.

On the Internet we now have a page on Facebook where we notify when clubs meet under the *Philas -The Philatelic Association of NSW* banner and have commenced a series of stories to add interest for the general public to our hobby.

Members from Adelaide clubs were given an invitation to attend the opening night of this exhibit and at least 10 members took up the offer to attend the opening and show our support of all the hard work that Martin had put into organising the display. It was a very successful night.
- June 2023 Martin Walker (Convenyor of Postal Stationery & Postal History Soc) gave a presentation on the collecting of Postal History at Tea Tree Gully . The talk dealt with the many interests that could be pursued in collecting postal history. The post offices at Tea Tree Gully and the means of carrying mail were featured with great interest shown in the mail coaches.
- Also in June 2023 David Figg, Gordon Oates and Jenny Roland were invited to attend a meeting at the Country Women's Association meeting rooms to discuss stamp collections and other philatelic collections. There were 9 frames of mixed displays and David,Gordon and Jenny gave a talk on Philately that covered the general forms of collecting from simple stamp collecting to the more specialized aspects of each presenters philatelic interests. There were many interesting questions on collecting in general and how to dispose of a collection.

• Website

The SAPC committee has developed an a website for the SAPC and its affiliated clubs. With the help of Diane Shaw (Publicity Officer) and Alex Littlewood (consultant) we have taken a step forward by establishing internet and social media presence to encourage retirees and youth interested in philately. The website has proved to be very popular. A member of Salisbury PS asked if we could look at creating a QR code, our Publicity Officer has created for us, members and the public now have access to this medium for access to our website. Job well done.




Tasmanian Stamp Council Report

Tasmania now has 5 active clubs with the creation of the Burnie and NW Districts Stamp Coin and Collectables Club Inc. recently. All clubs provide delegates to the Stamp Council which meets generally three times per year on a rotational basis around the State.

All clubs continue to be active with Devonport and Launceston conducting regular Market days.

The Tasmanian Philatelic Society conducted a National one-frame exhibition which attracted 71 competitive entries in May this year. The exhibition was a success by all accounts with visitors from all Australian States and locally. The Council provided a prize for the Best in Show.

The Tasmanian Stamp Council currently has several projects underway on behalf of members:

- The development of a Tasmanian inter-club competition
- A project to counter fraudulent seller(s) on eBay. We hope to take this project to other States once we have made some progress within our State.
- Clarification from the Tasmanian State Government on the status of collections of German Third Reich philatelic material given a recent State Act which makes display of Nazi symbols a criminal offence. We have been advised that the Act does exempt historical and artistic displays and its likely that showing stamps and philatelic items at exhibitions and club meetings would fall under the exemption. The sale of such material is a little less clear. Other States have or will implement similar but not identical legislation as will the Federal Government.
- Development of an Ad promoting the 5 Tasmanian Clubs in the Tasmanian Seniors Week magazine to be published in October
- The TSC website is being re-developed at <u>https://www.tasmanianstampcouncil.com/</u>

The next meeting of the Stamp Council will be on 13 December and the above projects will be further progressed.

Affiliated Clubs and Societies

There are 26 clubs and societies affiliated with the VPC. Thirteen clubs are in the Melbourne Metropolitan area and 12 are in country Victoria. Sadly, the two clubs that catered for specialist international interests, the Polish and Italian clubs closed due to a lack of members.

For the first time we have managed to get email addresses for all clubs and all future correspondence will be electronic. We have found that it is better to send communication to more than one email address to ensure the VPC message is given to the club.

Victorian Clubs' Competition

The VPC held the inaugural Clubs' Competition at the Brighton Philatelic Society on Sunday 30 April 2023. The rules were:

- Participation was open to Victorian clubs, or an individual member of an organisation affiliated with the VPC.
- The winning entry and club were decided by popular vote.
- Each club could enter a minimum of 2 exhibits or a maximum of 4 exhibits that were at least 1 frame or a maximum of 5 frames. Only the top 2 scoring exhibits for each club counted towards their total score.
- An exhibit that had been awarded 75 points or higher at the National level was not eligible to enter.
- An exhibitor could opt to have their exhibit judged by the VPC jury for feedback.



The competitions attracted 48 frames of displays from eight societies. Many were firsttime exhibitors. The winning entry was the *Engraved Stamps of Australia 1913 - 1914* by Joe Edwards for the Balwyn Club, and the winning club was the Brighton Philatelic Society. The day proved to be very popular with participation from a few dealers, door prizes and free pizza and drinks provided for lunch. The VPC also held its Congress that day. We received good feedback and will hold a similar event in November 2024.

VPC Congress

Issues arising from the congress were as follows.

- A need for more use of social media in attracting members, especially people from the 30-50 age bracket and the early retiree cohort.
- Clubs need to forward their year's activities or club syllabi to the secretary to give the clubs a voice on the web.
- It would be good if clubs could ensure they had a link to their websites and kept their web pages current.
- Small clubs found that their meetings were simply social gatherings that enjoyed circuit books when they were made available.
- In the main, clubs were happy to maintain the status quo rather than take on new challenges.

Two State exhibiting events have been held since the last AFP AGM, SWANPEX 2022 and SWANPEX 2023

SWANPEX 2022 was held in conjunction with the Perth Stamp and Coin Show at the South Perth Community Centre on 30 Sep. and 1-2 October. As usual the exhibits were of a high standard with the judges awarding 5 Gold, I Large Vermeil. 2 Large Silver and I Silver. Best in Show was Bruce Hayne's 'Ceylon Pence 1857-1871'. The 2022 Hasluck Medal was presented by Nicholas Hasluck to Kevin Kealley of the Busselton Stamp Collectors Club.

SWANPEX 2023 this year was held in conjunction with The Philatelic Society of WA Stamp Show at Gloucester Park in East Perth On 22-23 July as a trial run at the venue for Perth 2023 National Stamp Exhibition. The pleasing aspect of the show was the increase and very high standard of the Club Class exhibits. 6 Gold Medals, 2 Vermeil and 2 silver were awarded by the judges. Best in Show were 'The Bolivian Revenues to 1906' from Glen Stafford. This years Hasluck Medal was presented to Ross Edwards, WAPC Vice President, for his services to WA philately over many years.

The states only youth club at the Margaret River Primary School has continued to thrive under the management of Primary School Teacher Richard Dowling. This club is being well supported by the other clubs around the state. A youth website is still being worked on and should be up and running in the next few months.

Work is still progressing on the new state exhibiting medal, a design has been chosen and will advance to the proof stage shortly.

The main WAPC focus is now on the Perth 2023 National. A strong committee has been formed and planning is progressing well for 800-900 frames, international, interstate and local dealers. The Royal Australian Mint, the Perth Mint and Australia Post will all be in attendance and the show will also incorporate a display of antique radios to commemorate 100 years of radio in WA and the display and riding of antique cycles. Development Officer John DiBiase has organized workshops on displaying to assist first time exhibitors.

WA exhibitors have continued to exhibit internationally with several Golds coming back to the State.
